The Local Plan was very high on our list of priorities before Christmas and an excellent response to the Plan was sent to EFDC from the Society. The consultation closed on 12 December after which we became aware of significant additional information about each of the three sites proposed for development. We sent a further letter of objection that this information was not included in the Draft Local Plan and it would seem the last letter has been read by those dealing with the Local Plan. (you can read our responses on our web site). A recently published EFDC interim report on the Plan states that c3,300 people responded to the consultation: slightly over half said they strongly disagreed with the overall vision set out in the documents.

The Society has now fully entered the 21 century. Margaret Drew works daily at keeping Facebook fresh and interesting; Peter on Nextdoor (formerly StreetLife); and Anthony, Twitter. Follow us on all three. And of course we still have an interesting website.

PLANNING

Yet another Newsletter and no let up in the number of applications and the never ending quest to increase the number of dwellings in the area as well as the size of those dwellings.

Your committee objected to the proposals to extend both 31 and 33 Amberley Road. These two bungalows were previously a single bungalow and BHRS, the Parish Council and EFDC Plans South all objected to the proposal for an additional bungalow on this site. This was overturned by the Planning



Inspectorate and permission was granted. Both of these applications have been granted.

There have been applications for a rear extension to 71 Princes Road the first of which was refused. The current scheme is yet to be decided upon although BHRS's Committee and the Parish Council have voiced concerns over the impact this extension will have on neighbouring properties.

A further application for a new dwelling adjacent to 2 Gladstone Road was submitted, objected to and refused permission by EFDC.

Buckhurst Hill Football Club applied for permission to change the use of open fields within the Green Belt in Roding Lane to playing fields and for the formation of a new car park. Objections were raised basically on the construction of the car park, as the use of Green Belt land as football pitches is an acceptable use. We also requested that no further development of the built facilities should be allowed in the future. If additional accommodation was required for the increased number of pitches then it should have formed part of the application. We have also requested an Ecological Survey and a Flood Risk Assessment. We still await a final decision on this application.

Much public concern was raised over an application to build 4 houses in the rear garden of 18 Russell Road. This proposal was objected to by the Parish Council and on the evening of a public meeting organised by one of the neighbours we heard that the application had been refused by EFDC Officers

Currently we have concerns over an application at 31 Kings Place which would destroy the unique



character of the area. The properties to the South remain as they have been for many years and this property is one of a pair that remain on the North Side. We await the outcome of this application.

We are heartened that Epping Forest District Council is taking a strong line on opposing any rear garden developments that do not have direct access to a road.

FROM GOLD-DIGGERS TO REINDEER – CHEERS! Public houses, tea rooms and places of refreshment in Buckhurst Hill

The Christmas meeting of the Residents' Society is always something special, and this year was no different with the wonderful children's carol singing. But how to follow that? It was decided to have a light-hearted look at pubs and how refreshment opportunities have changed over the years. We began with an opening view of the much-missed Roebuck hotel, which dated back to the 17th or 18th century, although rebuilt in the 1890s. It retained a part of the original building as the bar, but the whole lot was sadly demolished in 2004. More than just a pub, more than a hotel, it was the venue for dances, meetings and weddings, and many people remembered Mrs Mills playing the piano there! Fortunately a little of



the Roebuck remains – the stag's head is on a building of St John's School.

The Bald Faced Stag, again of considerable age, although rebuilt after a fire in 1936, has, it seems, lost its name, and is now only known as the Toby Carvery – very sad; even the bus stop has been re-named Stag Lane.

The Prince of Wales had other names (such as B52) before being demolished to make way for the flats of the Atrium

There were many more pubs, of course; the Three Colts is still with us, and the Warren Wood, both dating from the 1860s. The site of the previous Parish Office (which many remember as the premises of Les George) was once a pub called the Title Deed; what is now Prezzo was the British Queen (with many other names in between). The Railway Tavern is still there, and the Monkhams Inn, but we have lost the Prince of Wales (now the Atrium flats), the Duke of Edinburgh and the Reindeer on the Epping New Road, and the Mother Hubbard on Loughton Way. There was once on the corner of the High Road and Gladstone Road a building known as the Red House; it had many uses over the years, but it began as a pub called the Gold-diggers Arms in 1868. It was a British Restaurant in the war.



Off licences existed in Queen's Road, but in the Victorian period, temperance was of some importance. Therefore it was necessary to have places where people could partake of tea and other wholesome beverages, such as the Princes Road Retreat, and Guy's Retreat (later replaced by Allworthy's ice cream factory). Trinity Terrace, on the Epping New Road, once had tea rooms.

Now of course we have a wide range of refreshment

places; some pubs remain but we have many cafés and restaurants. From Italian to Turkish, from Chinese to fish and chips, Buckhurst Hill has a good choice – let's get out there and support these local businesses!

AREA PLANS SOUTH MEETINGS

Following a debate at the Full Council meeting of Epping Forest District Council. a vote was taken regarding moving the Plans South meetings from Roding Valley High School to the Council Offices in Epping. The main reason for the move was given as Security and also better facilities for all those attending. We are sorry to have lost this venue which reinforced the view of local decisions being made locally.

FURTHER THREAT TO BUS SERVICES

In March the 167 bus route from Ilford was curtailed to terminate at Loughton Station instead of running on to Debden. We have now learnt that the 20 from Walthamstow to Debden may also be under threat in 2019. Transport for London have revealed that the total costs for these routes in Essex exceeded fare income by around £1.5m, of which £0.6m was repaid by Essex County Council. In April 2016 Essex CC abruptly withdrew this subsidy and TfL then held a public consultation on the 167. Despite overwhelming opposition of residents in Buckhurst Hill, Loughton and Debden, TfL decided to curtail the service to running between Ilford and Loughton only.

At the same time, the frequency of the 549 from South Woodford to Loughton was reduced from 60 to 70 minutes, allegedly to improve reliability, but this will mean that occasional passengers will no longer be able to just turn up at the same minutes past each hour; they will have to consult the timetable or face a long wait.

TfL are under further pressure to eliminate their current £500m subsidy from Central Government, and this will lead to a reappraisal of all routes which extend outside London Boroughs. TfL have explicitly stated that London should not subsidise services in adjoining counties.

We cannot disagree with that. Transport in Essex is the responsibility of the County Council, and BHRS will be joining with residents of Loughton and elsewhere to lobby Essex CC to negotiate with TfL to maintain services either by increasing fares on journeys within Essex or by restoring their subsidy by raising Council Tax. Essex CC must not be allowed to simply walk away from their responsibility, as they did last year with the 167, and pass the blame to TfL. The current contract for the 20 expires in 2019.
